## Select Board Meeting Minutes September 2, 2025

Discussion: The Town Manager summarized monthly department reports, noting completion of Brock School Road culverts, roadside mowing, hiring of one public works employee, library usage statistics (464 August visits), and mechanical issues with Truck 16 (see Item 13).

#### 5. FY 2024-2025 4th-Quarter Financial Report

Discussion: Town Manager reported a total year-end over-expenditure of \$1,243.99 (excluding Solid Waste) and a \$58,963.03 over-expenditure in Public Safety due to vehicle repairs and training/overtime costs; revenues exceeded estimates by \$175,269.47. Town Manager noted a \$57,000 Solid Waste budget overage due to increased tipping fees as well as a one-time \$20,000 special assessment from Maine Waste-to-Energy; matter referred to the Solid Waste Committee for the September 23 meeting.

#### 6. RSU 10 Withdrawal Petition Certification

Discussion: Town Clerk certified 119 valid signatures (minimum required: 98). No vote required; warrant article scheduled for November 4, 2025 Special Town Meeting.

#### 7. Draft Solar Farm Ordinance

Discussion: The proposed ordinance bans new commercial solar farms while allowing onsite residential/business arrays and aligns with Comprehensive Plan goals to preserve agricultural land.

Motion: Azalea Cormier made a motion to forward the proposed "Town of Buckfield Solar Farm Ordinance" to voters at the November 4, 2025 Special Town Meeting.

## 8. Special Town Meeting Warrant - November 4, 2025

Discussion: Key warrant articles include election to fill a Select Board vacancy (term to 6/30/2026); transfer of \$58,963.03 from Undesignated Fund Balance to cover FY 24-25 Public Safety overdraft; adoption of Solar Farm Ordinance; authorization to finance a replacement ambulance (amount not to exceed \$430,000; term TBD); and petition to withdraw from RSU 10 with appropriation of up to \$50,000 for that purpose. Board reviewed lease-purchase options (5-, 7-, 10-year) for a demo ambulance (maximum \$430,000). Decision deferred pending the November 4 Town Meeting vote. Current unit 451 remains out of service; backup rental cost is \$125 per day if unit 452 fails.
