Select Board Meeting Minutes January 3, 2023 at 6:30 PM In Person and Remote Participation via Zoom

CALL REGULAR MEETING TO ORDER AND DECLARE A QUORUM AT 6:32 PM. VICE CHAIRMAN AZALEA CORMIER CHAIRED THE MEETING.

Roll Call/Declare a Quorum

OLD BUSINESS

1. OLD CHURCH ON THE HILL

The Board had a discussion about the importance of public involvement in determining the future of the Old Church on the Hill. Selectman Fickett asked the Town Manager to put together an estimate of annual costs for the Old Church. Members of the public spoke about the potential of the Church, alternatives to the estimate the Town received, as well as concerns that the Old Church has been discussed by many boards with no solutions.

Vice Chairman Azalea Cormier made a motion to move to the next item on the agenda, Selectman Bob Hand seconded – VOTE – 3 Yes, Chairman Iveson did not vote, motion passed.

2. COMMUNITY DAY COMMITTEE

Selectman Sandra Fickett made a motion to change the name of the Community Day Committee to the Community Events Committee and to amend the bylaws as necessary, Vice Chairman Azalea Cormier seconded – Discussion – Vivian Wadas asked about the existing funds held in the Community Day Checking Account and the Community Day CD. The Town Manager researched their purpose and stated the interest earned on the initial \$5,000 in the CD are to be used to defer the costs of Community Day Celebration per the terms of the Buckfield Bicentennial Committee. – VOTE – All in favor (4-0)

2. APPROVE THE MINUTES OF THE DECEMBER 20, 2022 SELECT BOARD MEETING

Vice Chairman Azalea Cormier made a motion to approve the minutes of the December 22, 2023 Select Board meeting, Selectman Bob Iveson seconded – VOTE – All in favor (3-0). Selectman Sandra Fickett abstained as she was not present at the meeting.

3. 2023-2024 BUDGET EXPECTATION

Discussion ensued regarding the Select Board's expectations for the upcoming 2023-2024 budget. Selectman Mike Iveson suggested at or below the current budget if at all possible.

Selectman Sandra Fickett stated that there are very few businesses and households that are going to spend less than what they are currently spending. She suggested that we take a look at what the Town pays their employees and ensure that the Town is at least in line with the 25th percentile for salaries so we don't lose people and also look at areas that can be cut back if possible.

The Town Manager further discussed his plan for the 2023-2024 budget process beginning with a presented budget to the Budget Committee by February 1, 2023 and a the Select Board by March 1, 2023.

Vice Chairman Azalea Cormier made a motion to reappoint Cory Nicholson to a one-year term on the Old Church on the Hill Committee ending June 30, 2023, Selectman Bob Hand seconded – VOTE – All in favor (4-0)

Selectman Mike Iveson nominated Selectman Azalea Cormier to be Chair of the Select Board. Selectman Azalea Cormier nominated Selectman Bob Hand to be Chair of the Select Board.

Selectman Azalea Cormier called for a vote, all in favor of Selectman Bob Hand for Chair – VOTE – Yes 3, No 0, Selectman Mike Iveson did not vote.

Chairman Bob Hand nominated Selectman Azalea Cormier for Vice Chairman, Selectman Mike Iveson, seconded the nomination – VOTE – All in favor (4-0)

Selectman Mike Iveson made a motion to adjourn at 7:53 PM, Vice Chairman Azalea Cormier seconded – VOTE – All in favor (4-0)
