TOWN OF BUCKFIELD ANNUAL TOWN MEETING WARRANT FISCAL YEAR 2025-2026

TO: Cameron Hinkley, a Resident of the Town of Buckfield in the County of Oxford, and State of Maine.

GREETINGS: In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Buckfield in said County and State qualified by law to vote in Town affairs, to appear at the Municipal Center in said Town on Tuesday, the 10th day of June 2025 at 8:00 AM, then and there to act upon Articles 1 through 36 by secret ballot as set out below, the polling hours therefore to be from 8:00 AM until 8:00 PM.

ARTICLE 1: To elect a **Moderator** who will preside at said meeting.

ARTICLE 2: To elect one (1) Selectman for a 3-year term beginning July 1, 2025, and ending June 30, 2028.

ARTICLE 3: To elect one (1) Selectman for a 3-year term beginning July 1, 2025, and ending June 30, 2028.

ARTICLE 4: To elect one (1) **R.S.U. # 10 School Board Director** for a 3-year term beginning July 1, 2025, and ending June 30, 2028.

ARTICLE 5: To see if the Town will vote to raise and appropriate a total of \$548,415 for **GENERAL GOVERNMENT** operating expenses for fiscal year 2025-2026.

RECOMMENDED BY THE SELECT BOARD

The General Government budget includes Administration, Insurance, Assessing, and the Municipal Center.

Administration - \$370,005 Insurance - \$76,460 Assessing - \$45,000 Municipal Center - \$56,950

<u>ARTICLE 6</u>: To see if the Town will vote to raise and appropriate a total of *\$794,294* for **PUBLIC SAFETY** operating expenses for fiscal year 2025-2026.

RECOMMENDED BY THE SELECT BOARD

The <u>Public Safety</u> budget includes Fire, Rescue, Emergency Management, Animal Control, Streetlights, and Hydrants. The Fire and Rescue Department budgets are offset by revenue generated through contracts with Hartford and Sumner as well as billing revenue. Fiscal Year 2025-2026 proposed Public Safety Revenue (incoming funds) is **\$255,000** (to be accepted under Article **11**).

Proposed Budget (Costs) - Proposed Local Revenue (Income) = Total to be raised through taxation \$794,294 - \$255,000 = \$539,294

ARTICLE 7: To see if the Town will vote to raise and appropriate a total of *\$35,455* for the **PARKS AND RECREATION** operating expenses for fiscal year 2025-2026.

RECOMMENDED BY THE SELECT BOARD

The <u>Parks and Recreation</u> budget includes costs associated with maintaining facilities as well as costs associated with operating youth sports programs. This also includes maintenance to the Railroad Bed Recreation Trail. Some of these operating expenses are offset by revenue generated through various sponsorships and registration fees.

ARTICLE 8: To see if the Town will vote to raise and appropriate a total of *\$74,536* for the **COMMUNITY** operating expenses for fiscal year 2025-2026.

RECOMMENDED BY THE SELECT BOARD

The <u>Community</u> budget includes Community Events, Social Services, General Assistance, the Old Church, and the Zadoc Long Free Library. Some of these operating expenses are offset by revenue generated from donations, trust funds, surplus book sales, photocopy fees, and State reimbursements.

ARTICLE 9: To see if the Town will vote to raise and appropriate a total of \$136,340 for DEBT SERVICE for fiscal year 2025-2026.

RECOMMENDED BY THE SELECT BOARD

Fire Rescue Building: \$71,280

2021 Cat Excavator: \$21,700 – One (1) Remaining Payment

2005 E-One Quint: \$27,475 – Seven (7) Remaining Payments

2023 Ford F-450: \$15,885 – Three (3) Remaining Payments

This is a decrease of \$31,395 due to the payoff of the 2009 International and 2012 Peterbilt plow trucks.

ARTICLE 10: To see if the Town will vote to raise and appropriate a total of *\$1,193,407* for **PUBLIC WORKS** expenses for fiscal year 2025-2026.

RECOMMENDED BY THE SELECT BOARD

The <u>Public Works</u> budget includes the Public Works Complex, Public Works Operations, Summer Roads, Winter Roads, and Cemeteries.

Public Works Complex - \$18,280
Public Works Operations - \$498,327
Summer Roads - \$551,200
Winter Roads - \$114,100
Cemeteries - \$11,500

Local and State revenues (income) such as culvert installation reimbursement, motor vehicle excise tax and LRAP (Local Road Assistance Program) help to offset the overall cost of Public Works (to be accepted under Article 12 and 13).

ARTICLE 11: To see if the Town will vote to raise and appropriate a total of \$308,635 for the SOLID WASTE operating expenses for fiscal year 2025-2026.

RECOMMENDED BY THE SELECT BOARD

The <u>Solid Waste</u> budget includes the full cost to operate the Buckfield-Sumner Solid Waste Facility. The amount to be taxed to the taxpayers of Buckfield is reduced by the Town of Sumner's 35% share of the budget through the acceptance of local revenues in Article 12.

Proposed Budget (Costs) - Proposed Local Revenue (Income) = Total to be raised through taxation \$308,635 - \$107,940 = \$200,695

ARTICLE 12: To see if the Town will vote to accept and appropriate the projected **Local Revenues** of *\$857,070* to reduce the 2025-2026 Appropriations Budget.

RECOMMENDED BY THE SELECT BOARD

Approval of Local Revenues reduces the amount to be taxed.

ARTICLE 13: To see if the Town will vote to accept and appropriate the projected State Revenues of *\$536,300* to reduce the 2025-2026 Appropriations Budget.

RECOMMENDED BY THE SELECT BOARD

Approval of State Revenues reduces the amount to be taxed.

ARTICLE 14: To see if the Town will vote to authorize the Select Board to appropriate up to \$300,000 from the undesignated fund balance and apply the total amount to reduce the fiscal year 2025-2026 appropriations budget.

RECOMMENDED BY THE SELECT BOARD

ARTICLE 15: To see if the Town will vote to authorize the Town Treasurer, upon approval of the Select Board, to apply the revenue received in excess of the 2024-2025 proposed Rescue Department Revenue of \$240,000, to the Rescue Department Capital Asset Reserve account and be used for the future purpose of replacing and/or remounting ambulances.

The ambulance replacement plan relies on this allocation of excess revenue to cover the costs associated with remounting or replacing aging units. Without allocating this revenue the Town will have to finance the refurbishment or replacement of ambulances as needed. If there are no excess funds, no funds will be applied.

ARTICLE 16: To see if the Town will vote to set November 15, 2025 as the due date for the first half of the 2025-2026 property taxes and May 15, 2026 as the due date for the second half of the 2025-2026 property taxes; after which interest will be charged at the rate of 4% per year, or part thereof, on taxes unpaid after the date in accordance with 36 M.R.S. § 505(4).

Per 36 M.R.S. § 505(4), the maximum rate of interest that can be charged is 7.5%; the Treasurer of State sets this rate each year.

ARTICLE 17: To see if the Town will vote in accordance with 36 M.R.S. § 506(A), to pay no interest on refunds of overpaid or abated taxes.

36 M.R.S. § 506(A) provides the rate of interest may not exceed the rate set for delinquent taxes, nor be less than that rate reduced by 4%.

ARTICLE 18: To see if the Town will vote to authorize the payment of tax abatements approved by the Select Board from the property tax overlay or, if necessary, from undesignated fund balance.

ARTICLE 19: To see if the Town will vote to accept prepayment of taxes to the Tax Collector for fiscal year 2025-2026 prior to the date of commitment and to pay no interest thereon.

ARTICLE 20: To see if the Town will vote to authorize the Select Board to sell by bid or auction, such equipment, vehicles, or furniture valued at or over \$5,000 as are no longer necessary for Town operations.

ARTICLE 21: To see if the Town will vote to authorize the Town Manager to sell by bid or auction, or on such terms and conditions he/she deems to be in the best interest of the Town, such equipment, vehicles, or furniture valued under \$5,000 as are no longer necessary for Town operations.

ARTICLE 22: To see if the Town will vote to authorize the Select Board and Town Manager to apply for State, Federal, and other grants on the Town's behalf for purposes they deem to be in the best interests of the Town; to accept such grants, including, when necessary, the authority to sign contracts and related documents and accept conditions of approval; and to appropriate and expend such grant funds for the authorized purposes for fiscal year 2025-2026.

<u>ARTICLE 23</u>: To see if the Town will vote to authorize the Select Board to negotiate and execute multi-year contracts not to exceed three years, including but not limited to, contracts or agreements in the following areas: auditing, tax assessing, solid waste disposal, fire, rescue, equipment purchasing, leasing and maintenance agreements.

ARTICLE 24: To see if the Town will authorize the municipal officers to dispose of tax-acquired property via quitclaim deed by either (A) offering the property to the former owner(s) or if deceased, to his/her/their heirs/devisees/personal representative for a price equal to all outstanding taxes, interest, fees and costs; or (B) using the process required by 36 M.R.S. § 943-C, provided that if the board is unable to list or sell the property as required by § 943-C(3), the board may sell the property through a competitive sealed bid process in which a notice advertising sale of the property shall be published at least twice in a newspaper of general circulation in the county. For sales other than to the former owner, excess sale proceeds, as defined in 36 M.R.S. § 943-C, shall be returned to the former owner.

ARTICLE 25: Shall an ordinance entitled 'Town of Buckfield, Fire Department Billing and Restitution Ordinance' be enacted?

The purpose of the proposed ordinance is to allow the Town of Buckfield to recover expenses incurred by the fire department when responding to certain types of incidents. This ordinance is specific to non-residents of Buckfield, companies, and specific mutual aid calls for service in which Buckfield Fire Department is the only agency providing the billable service. Cost recovery is becoming a more common practice as departments face rising costs and pressure to keep costs to the taxpayers as low as possible. A copy of the proposed ordinance is attached.

ARTICLE 26: To see if the Town will authorize the Select Board to accept gifts, real estate, and certain funds, including trust funds (hereinafter collectively referred to as "the Gifts") on behalf of the Town under such terms as they deem advisable, spend the Gifts for the purposes intended as allowed by law and establish reserve funds as necessary in order to give effect to the Gifts.

ARTICLE 27: To see if the Town will vote to appropriate 75% of the refund of Snowmobile Registrations, received annually from the Maine Department of Inland Fisheries and Wildlife to the Streaked Mountaineers Snowmobile Club for maintaining trails and bridges, on the condition that those trails be open to the public for snowmobile purposes at no charge in the snow season.

ARTICLE 28: To see if the Town will vote to authorize the Treasurer, with the approval of the Select Board, to waive foreclosure on any tax lien during the course of the fiscal year, leaving the Tax Lien Mortgage in full force and effect as provided for in 36 M.R.S.A. § 944(1).

ARTICLE 29: To see if the Town will vote to authorize the Select Board to expend an amount not to exceed the 2024-2025 approved budget for any department in which the proposed 2025-2026 budget is rejected, or until such time a new budget is approved by the Town at a Special Town Meeting.

ARTICLE 30: In accordance with 30-A M.R.S.A. § 5654, to see if the Town will vote to accept a gift of real estate from the Estate of James E. Jordan (the "Estate"), for the residence located at 150 Depot Street, along with a two acre parcel surrounding the building located at 150 Depot Street, being a portion of the parcel described in a deed recorded in the Oxford County Registry of Deeds at Book 1212, Page 11, and depicted on the Town's tax maps as Map 6, Lot 4-2, for the purpose of providing a location for the training and support of the Town's rescue unit, and to take any other action relative thereto, whereas non-acceptance of this gift would result in the property being devised to the nearest chapter of the Hells Angels Motorcycle Club of North America along with the residuary of the Estate, which includes but is not limited to approximately \$850,000 to be used to create a fund for the maintenance of any real estate accepted by the Town from the Estate, with the fund's income being used to maintain the properties in alternating years, with any unspent income reinvested into the principal and with the funds to be invested solely in government-insured bank deposits, along with any other property in the residuary estate.

ARTICLE 31: In accordance with 30-A M.R.S.A. § 5654, to see if the Town will vote to accept a gift of real estate from the Estate of James E. Jordan (the "Estate"), for the remaining property located at 150 Depot Street, of approximately 13.9 acres, being a portion of the parcel described in a deed recorded in the Oxford County Registry of Deeds at Book 1212, Page 11, and depicted on the Town's tax maps as Map 6, Lot 4-2 for the purpose of providing recreational opportunities to the public, and to take any other action relative thereto, whereas non-acceptance of this gift would result in the property being devised to the nearest chapter of the Hells Angels Motorcycle Club of North America, along with the residuary of the Estate, which includes but is not limited to approximately \$850,000 to be used to create a fund for the maintenance of any real estate accepted by the Town from the Estate, with the fund's income being used to maintain the properties in alternating years, with any unspent income reinvested into the principal and with the funds to be invested solely in government-insured bank deposits, along with any other property in the residuary estate.

ARTICLE 32: In accordance with 30-A M.R.S.A. § 5654, to see if the Town will vote to accept a cash gift of \$50,000 from the Estate of James E. Jordan (the "Estate"), to be used to establish the "Fred and Mae Cooper Memorial Scholarship Fund", with the income to be used exclusively for scholarships for students whose families are residents of the Town of Buckfield and are in their third-year of college or university, and with any unused income to be added to the fund's principal and invested only in government-insured bank deposits, and to take any other action relative thereto, whereas if the Town rejects the cash gift in this Article, the cash gift will be added to the residuary estate, and if the Town has rejected either of the gifts of real estate in Articles 30 and 31, the rejected real estate and the residuary of the Estate will be devised to the nearest chapter of the Hells Angels Motorcycle Club of North America, whereas if the Town has accepted both gifts of real estate in Articles 30 and 31, but rejects the cash gift in this Article, the cash gift will be added to the residuary estate to establish a fund for the maintenance of any real estate accepted by the Town from the Estate, with the fund's income being used to maintain the properties in alternating years, with any unspent income reinvested into the principal, and with the funds to be invested solely in government-insured bank deposits, along with any other property in the residuary estate.

ARTICLE 33: In accordance with 30-A M.R.S.A. § 5654, to see if the Town will vote to accept a cash gift of \$50,000 from the Estate of James E. Jordan (the "Estate"), to be used to establish the "Sarah Jordan Memorial Scholarship Fund", with the income to be used exclusively for scholarships for students whose families are residents of the Town of Buckfield and are in their third-year of college or university, and with any unused income to be added to the fund's principal and invested only in government-insured bank deposits, and to take any other action relative thereto, whereas if the Town rejects the cash gift in this Article, the cash gift will be added to the residuary estate, and if the Town has rejected either of the gifts of real estate in Articles 30 and 31, the rejected real estate and the residuary of the Estate will be devised to the nearest chapter of the Hells Angels Motorcycle Club of North America, whereas if the Town has accepted both gifts of real estate in Articles 30 and 31, but rejects the cash gift in this Article, the cash gift will be added to the residuary estate to establish a fund for the maintenance of any real estate accepted by the Town from the Estate, with the fund's income being used to maintain the properties in alternating years, with any unspent income reinvested into the principal, and with the funds to be invested solely in government-insured bank deposits, along with any other property in the residuary estate.

ARTICLE 34: In accordance with 30-A M.R.S.A. § 5654, to see if the Town will vote to accept a cash gift of \$100,000 from the Estate of James E. Jordan (the "Estate"), to be used to establish the "Carl and Beulah Jordan Memorial Scholarship Fund", with the income to be used exclusively for scholarships for students whose families are residents of the Town of Buckfield and are in their third-year of college or university, and with any unused income to be added to the fund's principal and invested only in government-insured bank deposits, and to take any other action relative thereto, whereas if the Town rejects the cash gift in this Article, the cash gift will be added to the residuary estate, and if the Town has

rejected either of the gifts of real estate in Articles 30 and 31, the rejected real estate and the residuary of the Estate will be devised to the nearest chapter of the Hells Angels Motorcycle Club of North America, whereas if the Town has accepted both gifts of real estate in Articles 30 and 31, but rejects the cash gift in this Article, the cash gift will be added to the residuary estate to establish a fund for the maintenance of any real estate accepted by the Town from the Estate, with the fund's income being used to maintain the properties in alternating years, with any unspent income reinvested into the principal, and with the funds to be invested solely in government-insured bank deposits, along with any other property in the residuary estate.

ARTICLE 35: In accordance with 30-A M.R.S.A. § 5654, to see if the Town will vote to accept a cash gift of \$20,000 from the Estate of James E. Jordan (the "Estate"), to fund an annual trip to Portland Head Light for the senior citizens residing in the Town, and to take any other action relative thereto, whereas if the Town rejects the cash gift in this Article, the cash gift will be added to the residuary estate, and if the Town has rejected either of the gifts of real estate in Articles 30 and 31, the rejected real estate and the residuary of the Estate will be devised to the nearest chapter of the Hells Angels Motorcycle Club of North America, whereas if the Town has accepted both gifts of real estate in Articles 30 and 31, but rejects the cash gift in this Article, the cash gift will be added to the residuary estate to establish a fund for the maintenance of any real estate accepted by the Town from the Estate, with the fund's income being used to maintain the properties in alternating years, with any unspent income reinvested into the principal, and with the funds to be invested solely in government-insured bank deposits, along with any other property in the residuary estate.

<u>ARTICLE 36</u>: To see if the town will vote to authorize the Select Board to lease or sell, the Old Church on the Hill, to an individual, non-profit organization, or other group under the conditions that the building will be substantially stabilized and repaired and the exterior appearance of the building will remain similar to its original design.

The Old Church on the Hill needs substantial structural and cosmetic renovations. An engineering study of the steeple and roof was conducted in 2020 that identified needed repairs. The estimate at the time of the study placed those repairs at \$635,000. A second opinion was provided without a formal report in 2022 that with enough volunteers needed repairs could potentially be made for \$25,000. The Town has been unable to find volunteers to fundraise, coordinate additional opinions, or make repairs. The building continues to deteriorate and requires significant attention.

Town of Buckfield Fire Department Billing and Restitution Ordinance

1. Authority

This ordinance is adopted pursuant to municipal home rule ordinance authority and Title 30-A M.R.S.A. § 3001.

2. Purpose

The Town of Buckfield Fire Department is engaged in providing fire suppression, fire rescue, and fire safety services. The Town of Buckfield is organized as a municipality under the laws of the State of Maine; and in consideration of services rendered hereby desires to set the following billing and restitution ordinance for specific Fire Department services.

3. Definition of Services

The Town of Buckfield will seek payment for the cost of services provided by the Town of Buckfield Fire Department when responding to incidents involving non-residents in the Town of Buckfield, or upon request of mutual aid from other municipalities when those services are performed by Buckfield Fire Department only. Services for which the Town of Buckfield shall seek payment include:

- a. Scene and Safety Control at Traffic Accidents: Positioning of fire apparatus and personnel so as to protect the scene from other traffic and deny entry into the scene of unauthorized personnel. Law Enforcement can move traffic around the area the Fire Departments has deemed as the safe zone for the occupants of the vehicles and the rescuers on the scene. Scene control may also include initial assessment of victims, basic life support, safely staging other incoming agencies responding to this incident. Prioritizing victim for treatment and transport and may also include a pulled hose line for protection of people on scene from possible fires and fumes or residue from such things as gasoline and air bag propellants. The most important function is establishing incident command of the scene, which is the Fire Department's responsibility at emergency incidents of this nature, and to coordinate with other responding agencies for their needs at the scene.
- b. <u>Disentanglement and Extrication Operations from Vehicles</u>: Anytime a person has to be lifted or taken out of an emergency situation or forcible entry is necessary to gain proper access to victims, the Fire Department will assist ambulance or EMS (Emergency Medical Services) personnel in a coordinated effort or on their own. This could include, but is not limited to car accidents, industrial accidents, below grade rescues, or even high angle rescues to name just a few. Ropes, ladder devices, air monitoring equipment, self-contained breathing apparatus, hydraulic equipment, shoring, saws, cribbing, air bags are just a few types of equipment used in extrication operations.
- c. <u>Fluid and Hazardous Substance Mitigation at Traffic Accidents</u>: Anytime the Fire Department has to manage any fluids or hazardous substances through containment or absorption with pads, sand, or other means determined by the Department of Environmental Protection (DEP). Mitigation of all hazardous substances is performed in accordance with DEP regulations.

- d. <u>Vehicle Fires</u>*: Anytime the Fire Department have to contain or extinguish a fire in a motor vehicle. This includes but not limited to passenger cars, trucks, semi-trucks, tractor trailers, construction equipment, farm equipment, all-terrain vehicles, and snowmobiles. This includes the laying of hose lines and positioning a handline for the protection of individuals at the scene because of fire, smoke, or leaking fluids such as gasoline. Vehicle fires may also require the use of a suppression agent such as foam to help extinguish the fire.
- e. <u>Hazard Mitigation Operations</u>: Anytime the Fire Department personnel have to deal with a hazardous substance via containment or absorption with pads for carbon-based substances like gas or oil, or removal via pads and sand or other means permitted by the DEP. This could be a car accident, trucking accident or a fixed facility. The mitigation of all hazardous materials and substances is done in conjunction with the DEP.
 - * This may also include any lost or damaged equipment as a result of the incident.

4. Fees for Services Rendered

Upon adoption of this Ordinance, the Buckfield Select Board in their expressed authority is authorized to review and set the fees for Fire Department services as they deem in the best interest of the Town of Buckfield. Fees for services shall be limited to cost recovery.

5. Restitution and Billing Procedure

The Town may seek restitution for costs for Fire Department services by filing claims with the insurance companies that insure the individuals or companies involved in an incident where Fire Department services are provided. The Buckfield Select Board is authorized to enter into a Cost Recovery Agreement with a third-party billing company for the billing and collection of fees for Fire Department services through the filing of insurance claims. All such claims shall be submitted in the name of the Town of Buckfield. The Town shall only seek restitution for Fire Department services from insured individuals or companies.

The Buckfield Select Board is authorized to institute legal action to collect insurance claims that remain outstanding for more than 60 days. The Buckfield Select Board shall be authorized to write off claims, when a claim is not paid with a valid reason including insured not at fault, or if all attempts to contact the insurance company fail by any common method available.

6. Compensation for Third-Party Collection Services

Terms of compensation to the third-party billing company shall be agreed upon and approved by the Buckfield Select Board and set forth in terms of the Cost Recovery Agreement

7. Reserve Account

All monies collected from the above billing, less costs of collection, shall be deposited into the Fire Department Capital Asset Reserve account.

8. Administration and Enforcement

It shall be the duty of the third-party billing company to effectively pursue the requirements of this Ordinance for payment of services rendered by the Fire Department as specifically outlined above.

9. Validity and Severability

If any Section of this Ordinance is declared by the courts to be invalid, such decision shall not invalidate any other section or provision of this Ordinance.

10. Conflicts with Other Ordinances

This ordinance shall not in any way impair or remove the necessity of compliance with any other applicable rule, ordinance, regulation, by law, permit, or provision of law. Where this Ordinance imposes greater restriction upon the use of Fire Department services, the provisions of this Ordinance shall control.

11. Effective Date

This Ordinance shall take effect upon adoption by the Town of Buckfield at its annual Town Meeting on June 10, 2025.
